### DOCUMENT SUMMARY/KEY POINTS

This policy outlines the medications that are able to be administered by a single Registered Nurse (RN).

## CHANGE SUMMARY

Modification of inclusion and exclusion criteria

Addition of Paediatric Nursing Clinical Assessment (PNCA) tool as assessment tool for:

- RN's with less than 3/12 experience in SCHN
- RN's on transitioning to paediatric practice programs (eg SIPP, First Year RN's)

Addition of RN's requiring up to date medication and paediatric life support competencies

NUM/NM and CNE/NE of clinical areas can elect not to implement policy

### 1 Introduction

These medications have been risk assessed as safe to be administered as a single Registered Nurse (RN) check medication at SCHN.

#### RN's who wish to single check medications must:

- Ensure that they adhere to the process outlined in NSW Heath Medication Handling Policy PD2013\_043.
- Have completed their annual medication and paediatric life support competencies

#### **Exclusions:**

- Enrolled Nurses
- Agency RN's
- RN's with less than 3/12 experience within the SCHN who have not successfully completed their PNCA (minimum of level 4 required in the medication component)
- RN's on transitioning to paediatric practice programs (eg, First year RN's, SIPP RN's), who have not successfully completed their formative PNCA's (minimum of level 4 required in the medication component)

#### Notes:

- 1) A Recognition of Prior Learning Plan can be implemented for nurses with recent paediatric experience.
- 2) If the nurse does not achieve a minimum of a 4 in their PNCA a time frame for reassessment is to be negotiated with the CNE/NE and the nurse.

#### Single check medicines can be administered with a double check

If a nurse is unfamiliar with, or concerned about a particular medicine, even if it on the single check list, it should be reviewed by a second nurse.

In clinical areas where the nurse management/education has decided not to implement the policy

Brand names have been included for some combination products which are prescribed brand name. The brand names of medicines the hospitals stock can change frequently and this policy may not reflect the brand currently available.

Medications which do not appear in this document must be double checked at each administration by 2 members of staff as outlined in the NSW Health Medication Handling Policy PD2013\_043. Please use the policy feedback function to nominate medications that you think should be evaluated for inclusion in this policy in the future.

ALL rectal and vaginal administration of medications requires two nursing staff to be involved with these routes of administration, regardless of the safety of the medication being administered.






